Membership Terms & Conditions

General Information:

1. Membership is not transferrable.
2. The club recommends the member(s) to participate in the annual meetings and other interim meetings of the club.
3. Official communication of the club is through E-Mail or Post.
4. Changes in the contact details filled above (Address, Email, Phone No.) should be notified to the club.
5. For family membership, the maximum age limit of a child is 16 years, after which individual registration is required.

Membership Fee:

1. Membership contribution (per year)
 - a. Family (2 Adults, 2 Children below 16): 35€
 - b. Working professional: 25€
 - c. Student: 10€
2. Membership will be extended for the following year automatically.
3. Membership fee must be transferred within 4 weeks, upon confirmation of membership from the club.
4. Membership fee must be transferred to the club account. The bank details of the club account will be sent to the members separately.
5. The membership fee mentioned above is fixed for the year 2019. It is subjected to change for the following years.
6. Membership fees will be used for the purposes mentioned in the by-laws.
7. Members are free to make voluntary donation(s) for the welfare of the Club.

Membership Cancellation:

1. The cancellation of the membership for the following year should be communicated through E-Mail/Post to the club before 1st of December in the current year.
2. Membership fee is not refundable.
3. The club reserves the right to cancel the membership upon misconduct.
